



Gamston Parental Funding Agreement

Dear Parent/Carer

The government have announced that your child is eligible for 15 or 30 hours funding.

For more information about eligibility visit www.childcarechoices.gov.uk This website will provide parents with a single point of information for all government funded childcare offers, including - 15 or 30 hours Tax Free Childcare. The Childcare Choices website includes a Childcare Calculator (www.gov.uk/childcare-calculator) for parents to compare all the government's childcare offers and check what works best for their families.

What does this mean for my child at Paper Moon?

At Paper Moon, after much consideration, we have taken the decision to enable all parents to access the 15 or 30 hours funding for children, whilst also carefully considering what the impact would be on our setting.

In order to offer this and remain sustainable, an additional sundry charge (*as described within Government guidance*) has been put into place.

This covers a contribution towards meals etc, which is also discussed in the:

Department for Education Early Years Entitlement: Operational Guidance

*"Government funding is intended to deliver 15 or 30 hours a week of free, high quality, flexible childcare. It is not intended to cover the costs of meals and snacks, consumables and optional activities. Parents can therefore expect to pay for any meals offered by the provider alongside their free entitlement Parents can also expect to pay for other consumables or additional activities offered by the provider, such as nappies or trips.
..... However, providers must offer alternative options for parents. This could include, for example, allowing a parent to bring in their own packed lunch"*

If you choose not to take up our "Enhanced Offer," the following alternatives are available:

Option 1

15 funded hours per week during term time (38 weeks), from 1:00 pm to 6:00 pm.

Option 2

24hrs a week over 47.5weeks (4x 1-6pm and 1x 1-5pm)

A light afternoon snack will be provided, with a voluntary contribution requested.

All children aged 3 and 4 are entitled to 15 hours of government-funded early education per week, for 38 weeks per year. There is no charge for these funded hours.

Some 2-year-olds may also be eligible for 15 hours of funded early education. Paper Moon Nurseries provides places for eligible families, and no fees apply for these sessions.



Additional service charges

This is charged at £25 per day £15.50 for half day (see below for costing breakdown) Due to the invoicing system we use, this charge will appear on the invoice as a monthly charge (ASC),
